Dear Sir and Dear Madam,

We are very happy about your interest in joining the Guelph Party and we are happy to inform you of the conditions required of the Aspirants for admission, and what commitments are required of the members.

Asking to be part of our Archconfraternity represents a precise choice of active militancy, which contemplates the commitment aimed at one's spiritual growth and the testimony of Christian life. Absolute fidelity to the principles of brotherhood and unity, as well as to Christian values and to the Pontifex Maximus, on whom the birth of the Guelph party directly depends historically, morally obliges all members to a continuous commitment, based on their own possibilities and abilities, in the activities of the Archconfraternity, for life.

Becoming a Guelph Knight or Dame does not represent an honor but a service. This important choice is formalized with an oath taken at the time of investiture, with which one assumes for life a commitment to active participation, charity, brotherhood and obedience to the rules of the Guelph party, Christianly oriented towards environmental protection and to the enhancement of the historical-cultural traditions of the City of Florence. Failure to comply with the commitment undertaken may result in the revocation of membership according to the unquestionable judgment of the Council of Belief, and consequently of the use of the title and insignia conferred upon investiture.

With this premise, in addition to the basic requirements for admission which require the attestation of a profound and convinced adherence to the statutory principles of the Guelph Party, of an exemplary conduct of life, of true morality, of a demonstrated predisposition to charity and of true interest in the environment, the historical-cultural traditions of Florence, the common good, there are other evaluation elements that must be taken into consideration to verify the effective possibility of the candidate to comply with the commitments that belonging to the Guelph Party requires. The presentation of the application for admission therefore provides for cognitive and informative interviews with the Captains of the Guelph Party and a preparatory and verification attendance, to deepen mutual knowledge, for a period of not less than two months. After this time, the application for admission, accompanied by all the required documents, is submitted to the competence of the Council of Belief, whose unquestionable judgment rests with the decision to grant admission.

We take this opportunity to hope that your will be followed by hospitality in the Guelph party.

as an Aspiring member of the Guelph Party, assumes, pursuant to the Italian, Community and international legislation in force, the following commitment to confidentiality and the processing of information.

"Confidential information" means all information of any nature or form (including electronic, digital or verbal), analyses, works, studies, documents or other material, which are provided by the Guelph party.

With this confidentiality commitment, in relation to the information that will be provided by the Guelph Party, or that will in any case be acquired, the undersigned undertakes:

1. to consider the information communicated by the Guelph Party as strictly private and confidential and, therefore, not to disclose it and/or in any case not to disclose it to third parties;
2. to adopt all the precautions and measures necessary or appropriate - and in any case not less than those required by the Guelph Party - to protect the information and confidential documentation relating to the initiatives presented, in order not to jeopardize, in any way, the confidentiality of the information;
3. not to divulge any of the information communicated by any means, except for what is expressly permitted and authorized by the Guelph Party;
4. to use the information learned during the meetings and encounters only within the limits and in relation to the activities planned by the Guelph Party, for collective and not personal purposes;
5. in particular, the undersigned undertakes not to use confidential information in a way that could damage the Guelph Party or its members, or in such a way as to induce its adherents to cease to be such.

The validity of the commitments referred to in this agreement will start from the date of signing of the same. It will be the unquestionable right of the Guelph Party to interrupt the supply of confidential information. Any disputes that may arise following the disclosure of confidential information will be devolved to the exclusive jurisdiction of the Court of Florence.
